#### 4) Details of Grievance

The Consumer's installation has been disconnected around 24th Sept.1999 for non payment of outstanding Rs.1,56,466.00. This outstanding is for the period of non-occupancy of premises by the consumer during the period when the outstanding Bills were raised. Our factory which is located in a Industrial premises was under repairs and we have not used. Supply since 1992 upto 2001. Supporting Documents Collaborating our claims of non-use is attached as annexures.

#### 7) Nature of Relief Sought from Forum

Waiver of outstanding Bill of Rs.1,56,466.00 and Reconnection of supply to the premises for factory load.

Additional info. The present owner of the premises is a new buyer and was ignorant of any such encumbrances or liabilities arising out of the previous owner. A scrutiny of the case reveals that the liability of previous owner does not exist. However the new owner is desirous of early settlement of the issue.
